About Us

Established in 1996, Sammilani Mahavidyalaya is considered one of the most reputed undergraduate colleges in south Kolkata. Located within 300 meters from Baghajatin Rail Station, 50 meters from the E M Bypass and 100 meters from Satyajit Roy Metro Station, Sammilani Mahavidyalaya offers modern subjects like Computer Science, Microbiology, Molecular Biology, Film Study, etc. in addition to subjects of all time demand like Bengali, English, Sanskrit, Physics, Chemistry, Mathematics, Education, Economics, Geography, History, Philosophy, Political Science, Zoology, Botany etc. for both Hons. and General programmes. All the departments offer ad-on courses and the Placement & Career Development Cell organizes courses and programmes to improve employability of its students. In compliance with the NEP 2020, the college arranges internship with reputed companies for all students under CCF. Many of its alumni are pursuing their higher education and research in the country and abroad and are well placed in various services.

The college had been accredited thrice by the National Assessment and Accreditation Council in 2005, 2016 and 2024 with decent grades (B+, B++ and B+, respectively) for offering robust teaching-learning activities, providing advanced academic resources and infrastructure. About two dozen classrooms are equipped with computers and projectors for ICT enabled teaching-learning activities. The entire campus is covered with WiFi for the learners. The Central Library of Sammilani Mahavidyalaya is one of the best libraries in the city that houses more 25000 books for students. A medium sized play ground with a gallery surrounding it, multigym, two students' common rooms (separate for girls) and a canteen offer sports and game facility and quality time at Sammilani Mahavidyalaya.

Sammilani Mahavidyalaya was founded by some renowned academicians and educationists of the locality like Late Prof. Ramaranjan Mukhopadhyay and Prof. K. P. Majumder under the aegis of the Govt. of West Bengal with a definite objective to impart knowledge and skill to the young generation of the locality, southern parts of the city and state. Since its establishment, Sammilani Mahavidyalaya has been affiliated to University of Calcutta. On 5th June 2003, UGC granted the college the status to receive financial assistance U/s 12(B) of the UGC Act. 1965.

The admission and course fees for all the programmes are among the lowest in the region at Sammilani Mahavidyalaya. In spite of that the college authority does not compromise on the quality of education it provides. It has more than eighty professors in permanent positions in addition it engages guest teachers as and when necessary for running all the programmes efficiently. All the laboratories are equipped with advanced and state of the art equipment and facilities.
